For Mares which have been outside the UK & Ireland within the last 12 months:

- Signed Nomination Agreement
- Completed & Signed Details of Mare/Booking Form.
- Negative CEM Clitoral Swab certificate taken after 1st January 2025
- Negative EVA Certificate taken within 28 days of arrival in UK,
- Second Negative EVA Certificate taken 14 days after arrival at UK stud. and no more than 30 days before the cover (see overleaf).
- Further Negative EVA Certificate taken no more than 30 days before the cover (see overleaf).
- Negative EIA Certificate taken within 14 days of arrival in mainland Britain.
- Second Negative EIA Certificate taken 14 days after arrival at UK stud and possible further EIA test to be taken within 21 days prior to covering. **Plus** foal certificate if arriving from Italy or Germany (see overleaf).
- Negative Dourine Certificate dated within 28 days prior to arrival in this country for mares who have been in Italy since January 2012.
- Signed Freedom from Infection Form
- Passport (to arrive with the mare) showing updated influenza and tetanus vaccination record (Equine influenza vaccination must be given within **6 months** of arrival)
